- 6. That the school will not open classes under CBSE pattern particularly class XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- That the Principal and Correspondent /Manager of the school have individually gone 7. through the provision contained in the affiliation & examination byelaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination byelaws directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statuary requirement like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
